- 1. For a lung transplant, you first have to go through a screening test, against that mess.
- 2. Haven't Director Chen Jingyu, the president, done it this year? We are not very sure!
- 3. Transplants for the patients with new coronavirus are not performed here! We don't do such transplants here!
- 4. Now the hospital has the rules that all single- or multi-bed rooms must be used for singles only.
- 5. The lead surgeon must be Chen Jingyu. If a patient is accepted, it must be Chen Jingyu as the surgeon.
- 6. If you are a new coronavirus patient, even if you come to China-Japan Friendship Hospital, you still need to go through various levels of managers, because this is not a designated COVID-19 hospital.
- 7. Director Chen Wenhui is in charge of the postoperative management, the postoperative care of lung transplants, such as prescribing the drugs.

Investigator: Hello! Is this China-Japan Friendship Hospital? Is this the operator?

Operator: Yes.

Investigator: Could you please transfer me to Lung Transplant?

Operator: One moment please.

Investigator: Thank you!

Nurse: Hello! Lung Transplant.

Investigator: Ah, hello! Good afternoon. I'd like to ask, if I bring my father-in-law to your hospital for a lung transplant, I want to know what paperwork I should bring?

Nurse: Ah, you must, you must call our director. You have to go through the screening test, against that mess. Please first call the doctors' office, 84206291.

Investigator: 6291. About the director, I've read in the newspaper that Director Chen's come back to your hospital, right?

Nurse: Which Director Chen? Chen Jingyu? I am not too sure.

Investigator: Ah?

Nurse: I'm not too sure. He just finished that one a couple of days ago? (Interjecting: That's right.) I did not see it.

Investigator: As I just saw in that newspaper, he did a new coronavirus case at your hospital, then ...

Nurse: Not at our place, not here!

Investigator: It was done in Wuxi, not at your hospital?

Nurse: Yes, yes, yes, it was done in Wuxi.

Investigator: Ah ... President Chen is not in Beijing now, right?

Nurse: Correct. Please call our Director Chen Wenhui. You can call the doctors' office.

Nurse: No, now the hospital has the rules—all single- or multiple-bed rooms must be used for singles only. Don't we have the new coronavirus situation now? Right!

Investigator: That is right.

Nurse: Isn't it an abnormal period of time now? Yes, yes, yes, they must decide if patients meet the requirements for hospitalization.

Investigator: For lung transplantation, you don't do it for novel coronavirus patients, or everyone is okay?

Nurse: I am not too sure. For patients with novel coronavirus, we've never done it. This year, haven't Director Chen Jingyu, the president, done it? We are not very sure. Yes, yes, he did it in Wuxi.

Investigator: So do we accept such patients? Do you take novel coronavirus patients?

Nurse: No patient with novel coronavirus is accepted. No such a patient is accepted here in our program for sure.

Investigator: Oh. Aren't you the kidney transplant program? But you don't do transplants for novel coronavirus patients, do you? You don't take those novel coronavirus patients, right?

Nurse: We have never done that. I don't know anything about that, about their stuff!

Investigator: Ah, well, as I just saw it from the newspaper, I thought it was done at yours, China-Japan Friendship Hospital. So I just wanted to call first and find out the situation.

Nurse: You can ask, please check it out. Right now President Chen Jingyu should be out of Beijing.

Investigator: Director Chen Wenhui also does lung transplants? If Director Chen Jingyu cannot come, what about Director Chen Wenhui?

Nurse: She does not do it. She takes care of the postoperative management.

Investigator: Prescribing drugs?

Nurse: The management after the operations, yes, yes, yes, the postoperative care of the lung transplants, such as prescribing drugs, are all taken care of by her.

Investigator: The lead surgeon must be Chen Jingyu. If a patient is accepted, then it must be Chen Jingyu as the surgeon, right?

Nurse: Yes, that's right.

Investigator: Now I got it.

Nurse: Regarding novel coronavirus, you have to ask them.

Investigator: So how many beds do you have available now? Are you at full capacity? Is your hospital at full capacity now? Do I need to go through connections or just through the normal channel for admission?

Nurse: No, if you are a novel coronavirus patient, even if you come to our hospital, you still need to go through various levels of managers, because this is not a designated COVID-19 hospital.

Investigator: As far as the novel coronavirus is concerned, aren't you famous for treating the lung issues? Isn't Chen JIngyu famous for lung transplantation?

Nurse: Yes, even for regular lung transplantation, you need to talk to our director. She has to find you a bed and get to know your patient's condition before she can accept the patient. I would say you should, you should call that number, 84206294. Just talk to her. She will answer your questions. If you have a novel coronavirus patient, you'd have one more reason to talk to her.

Investigator: Ah. Is it 6294 or 6291?

Nurse: 629...84206291 is our doctors' office. 6294 is for the nurses' station. That's the one you're calling now, yes.

Investigator: 6294 is the one I'm calling, right?

Nurse: Yes, that's right, please call the doctors' office.

Investigator: Is there anybody if I call now?

Nurse: There should be, there should be someone there. Please call!

Investigator: Okay, thank you.

Nurse: Okay, okay, good, no problem.
