Investigator: Hello.

Red Cross Employee: Hello, I'm listening.

Investigator: A patient, who wants to do organ transplantation, heard about the organ

donation. I would like to ask about the organ donation situation at your place.

Red Cross Employee: May I ask whom I am speaking to?

Investigator: Well, I am, I mean I have a relative from Huludao, not far from here, and I am from Guangdong. I just want to know if you have organ donations. If you do, I will ask him to come to Tianjin. There is a Central Hospital, which is very good (at doing organ transplantation), right?

Red Cross Employee: Yes.

Investigator: I just want to know the situation of organ donation here. I just want to ask how many people have made donations.

Red Cross Employee: Well...what do you mean? You mean how many people have made donations since the establishment of our organ bank, right?

Investigator: Yes, yes, yes, how many?

Red Cross Employee: There have been more than 170 people, in Tianjin City, yes.

Investigator: Does this include body donations?

Red Cross Employee: No, the donors here are all healthy people, who are willing to donate to save the lives of patients.

Investigator: When did you begin accepting the donations, and how many years does it take to have the 100 plus donors? Since which year?

Red Cross Employee: Since 2003.

Investigator: 2003?

Red Cross Employee: Yes, right.

Investigator: There have been more than 100 donors since 2003, right?

Red Cross Employee: Right, right, right....

Investigator: Oh, I see. Are the donors all old or young?

Red Cross Employee: Both, relatively more people are young.

Investigator: (Did they pass away) due to illnesses or car accidents?

Red Cross Employee: Both. Pardon me? We only have healthy voluntary donors here.

They come here to get registered and go through tissue typing with the patients. That's all.

Investigator: I see. You have more than 100 (donors), who have got registered. But a successful donation will occur only after the donor's death, like in a car accident, right? His registration doesn't mean that he has successfully made a donation. So you mean there have been more than 100 people, who have donated here since 2003, right? Red Cross Employee: Yes, yes, yes...

Investigator: I see....Those people who have registered are all doctors and nurses, I heard, there are only doctors and nurses, right?

Red Cross Employee: Oh, no, no.

Investigator: That's not the situation? I see. May I have your director's surname? Red Cross Employee: Well, where are you from? We are not open to the public. Investigator: Oh, not open to the public. May I have your surname, then?

Red Cross Employee: May I ask where you are from?

Investigator: I just want to know about the donation situation at your place, because the donation...

Red Cross Employee: If you want to know about our donation situation, you could come to Shannxi Road in Heping District, you can come over to ask about this. Our telephone number is only used for the registration of voluntary organ donors, for this kind of things. Investigation: Oh, I see.

Red Cross Employee: I'm sorry about that.

Investigator: I would like to talk with your director, I want to know the....

Red Cross Employee: Sorry, our director is in a meeting right now.

Investigator: In a meeting? I can talk to him later. What's his telephone number?

Red Cross Employee: Well, it is not public information.
