Investigation Recording 30, Luo Gan's secretary didn't deny Luo's involvement in the live organ harvesting of Falun Gong practitioners.

Subject of Investigation: Mr. Yu, a secretary of Luo Gan, who was a member of the [Politburo Standing Committee](#) and the [Secretary of Central Political and Legal Affairs Commission](#)

On October 28, 2006, a WOIPFG investigator, posing as "an official from the 7th Bureau of the Ministry of National Defense" had a phone conversation with Luo Gan's secretary, Mr. Yu. During the conversation, Yu didn't deny Luo's involvement in the live organ harvesting of Falun Gong practitioners, and he only emphasized that it was "inappropriate" to talk about this issue on a regular phone line.

Phone Investigation Recording

Secretary Yu: Hello.

Investigator: Hello. Is that Secretary Yu of Luo Gan, the [Secretary of Central Political and Legal Affairs Commission](#)?

Yu: Where are you calling from?

Investigator: Oh. I'm from the 7th bureau of the Ministry of National Defense. We have an urgent matter that needs your cooperation. We are investigating some state secret leakage. We got a reliable report that certain officials from the Political and Legal Affairs Committee (PLAC) negotiated with overseas intelligence agencies to sell our state secret. Who from the PLAC has direct knowledge of the live organ harvesting from Falun Gong practitioners? Which departments and officials?

Yu: You are using a regular phone line, you...

Investigator: I know, because we are doing onsite investigation right now, so we have to narrow the (investigation) scale. We must know who had direct knowledge of this top secret.

Yu: So, you called me here.

Investigator: Ah.

Yu: We are out of town (i.e. not in Beijing).

Investigator: Oh.

Yu: First of all, we are not in Beijing. Second, you call me, but I cannot give you a clear explanation in a short conversation. What do you need from us? Do you have anything

specific?

Investigator: Ah, it's what I just mentioned.

Yu: Can you call from the bureau using the red phone line? To learn about something like this, do you have official documents and such?

Investigator: Yes, but we will have to wait until tomorrow. It's very urgent, so if we wait till tomorrow...

Yu: So use the red line (confidential phone line)!

Investigator: Ah?

Yu: I have connection to the red line here. You can use the bureau's red line to call me.

Investigator: I know, but we are not in the bureau. We are doing an onsite investigation. It will take some time for us to get to a red line. But we must know who had contact with the information about organ removal from Falun Gong members. So which level of officials within your PLAC had knowledge of this top secret?

Yu: What's your surname, please?

Investigator: My family name is Qiu.

Yu: Qiu? Tell me your number?

Investigator: 010-...

Yu: 010-...Ok, ok.
