## International Committee to Investigate Sujiatun **Concentration Camp**

Based on the concerned information and preliminary investigation, it had been verified that there is a secret concentration camp established in the Sujiatun District, Shenyang City, Liaoning Province in China. This concentration camp is suspected of purposely detaining and killing Falun Gong practitioners who refuse to give up their faith. Furthermore they harvest and supply victims' human organs to make huge profits. They have on site cremation chamber to cremate victim's corps in order to eliminate any trace of evidence. Based on the information source there are still large number of Falun Gong practitioners being detained at this facility and facing life threatening danger.

WOIPFG urge knowledgeable people to come forward with your best effort, providing detailed information on the names of organizations, institutions and individuals who participated or was involved with the killing of Falun Gong practitioners in Sujiatun Concentration Camp. Including but not limited to: participants who planed and implemented the establishment of the Sujiatun Concentration Camp; deputies and officials of the Judicial and Government System who participated in the abduction, transfer and killing of Falun Gong practitioners; administrators of medical institutions, organizations and medical personnel who participated in the harvesting and selling of human organs from Falun Gong victims; workers and other personnel who participated in the cremation of the victims' corps in order to destroy the evidence and other participating personnel who worked at Sujiatun Concentration Camp.
