## WOIPFG Announcement: The 7th Update on the List of Individuals and Organizations Suspected of Participating in the Persecution of Falun Gong

July 10, 2014

WOIPFG released the 7th Update on the List of Individuals and Organizations Suspected of Participating in the Persecution of Falun Gong on July 10, 2014.

The List includes 1,645 people from the 610 Office system, among which 355 hold active positions in various levels of 610 Offices. The List also includes 1,150 people from the Political & Legal Affairs Committee (PLAC) system. In addition, 6016 organizations and 12,555 individuals are included. These organizations and individuals belong to the different levels of CCP committees, public security, procuratorate, court, prison, and labor camp systems. The names are collected between March 3, 2013, when the 6th update was released, and July 7, 2014, through investigation and received reports. The updated information to the first four updated lists is also included.

The List was first released on Dec. 9, 2004, with 7 updates so far. There are all together 3,532 people from the 610 Office, 4,147 from the PLAC, 12,670 organizations, and 32,394 individuals from CCP committees, public security, procuratorate, court, prison and labor camp systems.

Since its establishment on Jan. 20, 2003, WOIPFG has been actively collecting information and updating lists of perpetrators. With the release of the 7th list, we wish to provide evidence and encourage the society at large to be steadfast in holding CCP responsible for its criminal conducts.
