All Perpetrators in the Persecution of Falun Gong Will be Brought to Justice!

Speech at Washington D.C. on July 17, 2014

Ladies and Gentlemen!

Fifteen years ago, the Chinese Communist Party (CCP) started the destruction of justice and conscience of humanity through the genocidal persecution of Falun Gong. In these fifteen years, the persecution has shown to lead to CCP's demise, while bringing the entire humanity to a gradual awakening. All perpetrators of persecuting Falun Gong will be brought to justice!

Given that CCP has destroyed justice and human conscience through the persecution of Falun Gong, it should face the investigation and judgment by the entire world. WOIPFG hereby publicizes evidence of crimes of CCP and the responsible individuals to help bring them to justice.

1. All Transplant Surgeons are Suspects of Live Organ Harvesting of Falun Gong Practitioners

WOIPFG issues warnings to organ transplant surgeons and associated personnel in Mainland China. Based on the huge discrepancy between the number of transplant cases conducted and the source of organs, accompanied by the enormous amount of evidence WOIPFG has collected, all transplant surgeons in Mainland China are suspected of participating in the live organ harvesting of Falun Gong practitioners, thus having committed the Crime of Genocide. You know that large numbers of people are being killed-on-demand for organs; you know they are Falun Gong practitioners. You should also know the consequence of the crimes!

WOIPFG will soon release a partial list of individuals suspected of participating in the organ harvesting of Falun Gong practitioners.

2. All CCP's Criminal Conducts are Documented!

By July 1, 2014, WOIPFG has issued over 5,000 notices of investigation and published 251 investigative reports. The investigative reports contain more than 1.7 million words and more than 5,300 pieces of evidence proving CCP's persecution of Falun Gong is systematic and genocidal.

On July 10, 2014, WOIPFG released for the 7th Addendum to the "List of Organizations and Individuals Suspected of Participating in the Persecution of Falun Gong," which includes 6,016 organizations and 12,555 individuals. The organizations and individuals belong to CCP Committees, Political & Legal Affairs Committees (PLAC), and 610 Offices at different levels, and Public Security, Procurators, Courts, Justice, Prisons, and Labor Camps.

Since the first release of the List on Dec. 9, 2004, with seven subsequent Addendums, the List now includes 3,532 people from the 610 Office system, 4,147 people from the PLAC system, 12,670 organizations and a total of 32,394 individuals. The List has been updated regularly and submitted to various concerned organizations, government agencies, judiciary bodies, media groups, and international courts, to assist the judicial proceedings around the world against these suspects. The evidence was provided by Falun Gong practitioners as well as other members of the society. WOIPFG has also received huge amount of evidence from awakened CCP officials and public security personnel. All criminal conducts of the CCP have been under the surveillance of the people, and have been documented.

On July 10, 2004, WOIPFG coordinated and established the “Global Monitoring & Tracking System,” which now covers nearly 500 cities in more than 110 countries around the world. This System has effectively monitored and tracked down CCP officials, who actively participated in the persecution of Falun Gong. Once they left China, the System would locate them, and would assist the victims and international attorneys to start the judicial proceedings against these suspects. For example, the former Head of Wuhan TV Station, the former Head of the “leadership team to handle Falun Gong Issues” at the Chinese Academy of Science, the former Jilin Province Party Chief, the Director of Guangdong Bureau of Reeducation through Labor, were all located, and successfully served with legal documents while staying abroad. In addition, the former Minister of Propaganda and member of the Politburo Standing Committee, Liu Yunshan was recently issued Notice of Investigation in June this year. The Chairman of the “Anti-Cult Association” of Zhejiang Province, Zheng Shusen was issued Notice of Investigation for his suspected participation in live organ harvesting of Falun Gong practitioners. In the meantime, this “Global Monitoring & Tracking System” also collects information on the assets of the suspects and family members, in preparation for freezing the assets and the investigation of the family members. For those criminals, there will be nowhere on Earth to hide.

4. The Only Way Out for Perpetrators is to Stop and Confess all Criminal Conducts

By persecuting Falun Gong, CCP has committed the crime of genocide and the crimes against humanity! The excuse of “Following Orders” cannot justify your actions. Just like the Nuremberg trials on the Nazis, each participant must assume his or her own responsibility. Confess, stop the evil deeds, report/publicize yours and other’s evil conducts, and do the right thing to make up for what you’ve done is your only way out. Of course, even if you do not confess, you will not be able to stop other people including your partners from reporting you. By then, you will then lose the opportunity to make up for your own guilt.

At present, the main culprits in the persecution of Falun Gong – the Head of the CCP Central 610 Office, Li Dongsheng, the Head of Political & Legal Affairs Committee, Zhou Yongkang, Chongqing’s Deputy Party Chief, Bo Xilai have all been brought to justice one after another. The next ones are Jiang (Zemin), Zeng (Qinghong), and Luo (Gan). CCP’s collapse is right around the corner.

WOIPFG calls for immediate actions by the Government of all countries, organizations and righteous people to thoroughly investigate CCP’s crimes against humanity! Let yourself stand on the side of the conscience and justice and do not miss this opportunity! For the sake of the upcoming judgment, the entire society should continue helping collect and provide the name list of suspects for the persecution of Falun Gong and their criminal evidence to coordinate with our organization’s investigation of the evil and stop the persecution!

WOIPFG will continue to investigate the criminal conduct of all institutions, organizations, and individuals involved in the persecution of Falun Gong, to bring such investigations, no matter how long it takes, no matter how far and deep we have to search, to full closure, to exercise fundamental principles of humanity, and to restore and uphold justice in society.
