# Public Notification by World Organization to Investigate the Persecution of Falun Gong on Doctors Who are Suspected to Have Participated in the Chinese Communist Party's Criminal Activities of Organ Harvesting from Live Falun Gong Practitioners

September 12, 2015

Since 1999, the former Chinese Communist Party (CCP) leader Jiang Zemin has manipulated the entire state apparatus, including the judicial system, military, armed police, and local medical organizations and carried out a massive genocidal massacre of Falun Gong practitioners through conducting nationwide organ transplants using organs harvested from live Falun Gong practitioners. This is crime of genocide and crime against humanity!

For more than nine years, World Organization to Investigate the Persecution of Falun Gong (WOIPFG) has carried out comprehensive and systematic investigations and obtained evidence on suspected organizations and individuals, and has collected more than 2,000 recorded conversations through over one thousand phone calls. In addition, WOIPFG has also done several rounds of systematic research and analysis of hundreds of thousands of papers written by more than 9,500 doctors, and has collected screen shots of hospital websites and database information as well as public media reports relating to 865 hospitals in mainland China that conducted organ transplants. As a result, more than ten thousand pieces of evidence have been obtained. Furthermore, through the process of verification, analysis, and argumentation of these pieces of evidence, WOIPFG concluded that the CCP is responsible for killing more than two million Falun Gong practitioners through live organ harvesting.

Based on WOIPFG's investigative results, the massacre is ongoing. We suspect that almost all the doctors in mainland China who have been involved in organ transplant surgeries are participating in the criminal activities of harvesting organs from live Falun Gong practitioners, and they are thus actively contributing to genocide!

This notice is issued by WOIPFG to notify all the doctors from mainland China who attended the ESOT 2015, 17th Congress of the European Society for Organ Transplantation in Brussels, Belgium between September 13 – 16, 2015 that cases will be filed to investigate their suspected criminal activities of organ harvesting from live Falun Gong practitioners. Whoever possesses evidence of these doctors' participation in these crimes is encouraged to contact WOIPFG.

Listed below are the primary organ transplant doctors from mainland China who attended the ESOT. Almost all of their names have been documented on the list and published by WOIPFG, including medical organizations and individuals who are suspected of participating in the removal of organs from live Falun Gong practitioners in mainland China.

WOIPFG's principles are: whoever has committed the crime is responsible for it; individuals are responsible for organized crimes; instigating a crime is the same as directly committing a crime. Based on these principles, all the crimes conducted in the name of organizations, units, and systems will eventually be the responsibility of the individuals. All the responsible persons who have participated in the persecution of Falun Gong will be investigated thoroughly and brought to justice.

We hereby warn those who have participated in the persecution of Falun Gong: the persecution of Falun Gong is a crime of genocide and a crime against humanity. It is the same crime committed by Nazi war criminals. Carrying out instructions can't be used as an excuse for impunity. All the participants must take personal responsibility. The only way out is to turn oneself in and confess, and to reveal more criminal evidence to make atonement.
