Moreover, we have identified 7,051 organizations and 13,332 individuals accountable for their roles in the persecution.

We hereby present a collection of WOIPFG investigative reports. From these reports, former CCP head, Jiang Zemin's genocidal policy of "ruining practitioners' reputations, cutting off practitioners' income sources, and destroying practitioners' physical bodies" can be clearly seen. We hope that this collection of reports will enable more people to see the truth of the persecution, realize the importance of condemning the CCP for the persecution, and speak up to demand an end to the persecution. The so-called self-immolation incident happened at 2:41pm on Jan. 23, 2001 in Beijing's Tiananmen Square. The shocking incident involving a few deaths has been used by the CCP regime to defame Falun Gong. Since early 2000, the number of organ transplant operations in China increased drastically. The normal wait time for liver or kidney in the international market is usually several years. But in China, it takes only 1 to 2 weeks. The exceedingly short wait time is alarming to experts. The boom of organ transplant in China coincides with the large-scale arrest, detention and disappearance of Falun Gong practitioners. WOIPFG conducted comprehensive investigation in China and obtained evidences that prove the existence of live organ harvesting from Falun Gong practitioners. This heinous crime has been committed under the systematic cooperation and protection of CCP's judiciary system, military and armed police forces hospitals. ## Book 19 The Global Monitoring System

The "Global Monitoring System" consists of individuals and human rights groups. The system operates a network covering over 300 cities in over 70 countries. WOIPFG is in charge of the general operation of the network. The mission of the Global Monitoring System is to monitor and locate all levels of CCP members who actively participated in the persecution of Falun Gong and help bring the CCP officials to justice. Since its inception, the network has successfully brought some key participants of the persecution to justice. Some of them, such as Zhao Zhizhen and Guo Chuanjie, spread CCP's hatred-filled propaganda in the media and scientific fields. Some of them directly participated in the organ harvesting of live Falun Gong practitioners, such as Shen Zhongyang and Chen Zonghua. Some of them are members of the "CCP Cult Association", such as Wang Wenzhong, Cheng Ningning and Chen Qingping.
