#### Summary

1. Investigator: If we want to queue at your hospital, how long will we have to wait to have the surgery done? Can we have it done within half a month, or one month?

Later on, the doctor told us to queue at a few more hospitals, saying that we should find a doctor as soon as possible and pick whichever hospital offers the shortest wait time. Well, through my friend and his recommendation, I found you. I'd like to ask, for example, if we want to queue at your hospital, how long will we have to wait to have the surgery? Can we have it done within half a month, or one month?

Doctor Ma: The chances may exist, but relatively, but are relatively small.

Investigator: Ah, relatively small? His doctor said that he has blood type B, which may make it easy for the tissue typing. I wonder if his tissue typing can be done at your hospital?

Doctor Ma: Well, let's do this: come to my outpatient clinic next Monday morning! Next Monday morning.

Investigator: Ah, sure. Now I'm wondering, shall I come with the patient together, or just bring over his medical records first?

Doctor Ma: The patient needs to come himself!

Investigator: Ah, the patient has to come?

Investigator: It sounds good. Okay, so we'll come see you then?

Doctor Ma: Come see me to have him registered as a walk-in patient. I will have him registered as a walk-in patient!

Investigator: Okay. Doctor Ma, it's not easy for me to get through a phone call. I'd like to ask about the price, how much is it?

Doctor Ma: I don't know.

Investigator: Ah, you don't know? Then how can...that is, based on his...

Doctor Ma: No telling over the phone!

Investigator: Ah, no telling over the phone.

Doctor Ma: Well, that's it. Okay, okay, that's it, bye now!
