#### Summary

In September 2014, WOIPFG investigated Bai Shuzhong, former Director of the Health Division of the Chinese People's Liberation Army (PLA) General Logistics Department. The investigation focused on the Chinese military's involvement in the live organ harvesting of Falun Gong practitioners. During the investigation, Bai Shuzhong admitted that Jiang Zemin, former Chinese Communist Party Chief, had "instructed" the harvesting of Falun Gong practitioners' organs for transplantation. From 1998 to 2004, Bai served as the Director of the Health Division of the Chinese People's Liberation Army (PLA) General Logistics Department. His tenure was the peak period of the CCP's persecution of Falun Gong practitioners and its live organ harvesting. The live organ harvesting of Falun Gong practitioners is mainly carried out by the Chinese military. So, as the highest medical administrative official of the military health system, Bai should be one of the people, who knew the situation best. As the top medical administrative official of the military health system, which is one of the specific executing agencies of this massacre, Bai Shuzhong should be the person directly responsible for conveying Jiang's massacre instructions and implementing this extinction policy.

The investigation result of this phone call directly points to Jiang Zemin, who ordered the live organ harvesting of Falun Gong practitioners. This is a genocide implemented by Jiang Zemin and other high ranking CCP officials and carried out by the CCP-controlled state apparatus. This genocide takes the form of live organ harvesting of Falun Gong practitioners.

#### Phone Investigation Recording

Investigator: Hello, is that Director Bai Shuzhong, former Director of the Health Division of the PLA General Logistics Department?

Bai: Ah, who is this?

Investigator: Oh... we would like to ask you for some information.

Bai: Ah...ah...you are...what is the matter, whenever you... what is the matter? You (can) go ahead...

Investigator: Here is the situation, when you were the Director of the Health Division for the PLA General Logistics Department, regarding excising organs from captivated Falun Gong people for organ transplantation, was it an order from Wang Ke, the then director of the PLA General Logistics Department? Or did it directly come from the Central Military Commission?

Bai: Back then, it was President Jiang.

Investigator: Okay.

Bai: Yes, there was an order, a sort of instruction.

Investigator: Okay.

Bai: There was an instruction

Investigator: Okay.

Bai: It said to start carrying out this thing, which is organ transplantation. Later, President Jiang, (I) heard, issued an instruction, about people selling kidneys for transplant surgeries, this, I should say, it was not just the military that was doing kidney transplants.

Investigator: We also obtained some information, that is, back then, the Joint Logistics Departments (of the Military Regions) were responsible for detaining a batch of Falun Gong people as live organ donors, right?

Bai Shuzhong: This, this, back then, ah, I think, at least this is how I remembered, back then, yes. Because back then, after President Jiang issued the instruction, we all did a lot of anti-Falun Gong work.

Investigator: Did you (the PLA General Logistics Department), the Joint Logistics Department No. 1 Subdivision, Joint Logistics Department No. 2 Subdivision and the Joint Logistics Department No. 40 Subdivision control the military hospitals, of which they were in charge?

Bai: We directly controlled the military medical universities, which are directly affiliated with the PLA General Logistics Department. They received repeated orders, because Jiang paid a lot attention to this matter back then and put a lot of emphasis on this matter.

Investigator: Who put a lot of emphasis on this matter?

Bai: Jiang, it was when Jiang was in power... (He) paid a lot of attention to this matter, there were instructions (from him).

Investigator: From 1998 to 2004, you were...

Bai: Right, right, I was serving as the Director of the Health Division, the Director of the Health Division for the PLA General Logistics Department, from 1998 to 2004.

Investigator: Well, this concludes our preliminary investigation.

Bai: Okay, Okay, good, in the future, if something comes up, you can ask me, no problem.

Investigator: Okay, good. Thanks, bye.

Bai Shuzhong: Bye.
