Investigative Report on the "610 Office" CCP Central Committee

Committee to Investigate the Crimes of China's "610 Office" in the Persecution of Falun Gong
December 1, 2003

Partial Name List of Officials in the Leadership Team to Deal with Falun Gong Problem and its affiliated "610 Office" in Chinese Communist Party Central Committee

Introduction

On June 10, 1999, CCP Central Committee (CCPCC) created a special agency to persecute Falun Gong. Its official title is "Leadership Team to Deal with Falun Gong Problem of CCPCC," and its affiliated office is "The Office of Leadership Team to Deal with Falun Gong Problem of the CCPCC." It is also called as "610 Office" due to the time it was created. It belongs to the party. Its corresponding office in the government is called "The Office of Preventing and Handling the Evil Cult Problem of the State Council." While in fact, the two offices are the same one with two different titles. To the outside, they are still "610 Office." The similar agency is created in all levels of administration in the party and the government. Since April 2002, CCPCC instructed to adjust and strengthen the "Leadership Team (Office) for Maintaining (Social) Stability." The function of "Leadership Team to Deal with Falun Gong Problem" in CCPCC [1] and some provincial and cities' [2] and their affiliated offices is later replaced by that of "Leadership Team (Office) for Maintaining (Social) Stability." In this report, the above terms can be exchangeable (with same meaning) from the source of materials. For how the "610 Office" operates, reference can be found in the part one of WOIPFG (World Organization to Investigate the Persecution of Falun Gong) "The Investigation Report on '610 Office'." [3] The "610 Office" has power in wide range from administration, judiciary, business to education. At the time when "610 Office" was created, another leadership team was setup also. The team is in charge of the nation-wide propaganda against Falun Gong. Our organization will have a special investigation report on their anti Falun Gong propaganda. This report only lists the personnel who participate in the activities.

Since the establishment of "The Office of Leadership Team to Deal with Falun Gong Problem" and its affiliated "610 Office" is classified, CCP has never published the name of the team and office's members. On June 7, 1999, in the speech at the meeting among the Politburo members of the CCP to discuss how to swiftly handle and solve the "Falun Gong problem", the former leader of CCP Jiang mentioned the leaders of the to-be created "Leadership Team to Deal with Falun Gong Problem." Li Lanqing is the team leader, Ding Guangen and Luo Gan are the assistant team leaders. [3] Hong Kong iMail reported that Jia Chunwang and Xu Yongyue were assistants in Luo Gan's persecution of Falun Gong. [4] Reported by www.bignews.com that, the assistant team leaders of the central "610 Office" are consisted of Luo Gan, Jia Chunwang, Xu Yongyue and Wang Maolin. [5] This list is actually the members of The Leadership Team to Deal with Falun Gong Problem of the CCPCC. "610 Office" is the team's affiliated office with Wang Maolin as the Director.

Xu Yongyue [10]: assistant team leader of CCPCC Leadership Team to Deal with Falun Gong Problem, the Minister of the Ministry of State Security.

Wang Maolin: assistant team leader of CCPCC Leadership Team to Deal with Falun Gong Problem, Director of the central "610 Office," [11] vice team leader of CCP Leadership Team of Political Propaganda Work, team leader of Leadership Team of National Crackdown on Pornography and Unlawful Action (from 2002 to 2003), [12] deputy chief committee member of Law Committee of National People's Congress (from 2002 to 2003). [13]

Li Dongsheng [17]: Deputy Director of the Central "610 Office" (from 2001 to 2002). Vice president and Party Secretary of CCTV.

Wang Xiaoxiang [18]: Deputy Director of the Central "610 Office" (Deputy Director of the Office of Preventing and Handling the Evil Cult Problem of the State Council) (Jan. 2003]. Previous Chairman of Youth Association of CCP State Agencies (October 1999).

Dong Jufa [19]: Inspector of the Central "610 Office" (Office of Preventing and Handling the Evil Cult Problem of the State Council) (2001)

Gao Xiaodong [20]: Assistant Commissioner of the Central "610 Office" (Office of Preventing and Handling the Evil Cult Problem of the State Council) (2003)

Liu Yunshan [21]: Minister of the Ministry of Propaganda of China, member of CCP Politburo, Director of CCP Secretariat. Director of the CCP Civilization Manages. Previous Routin Deputy Minister of the Ministry of Propaganda. He mainly oversees the national propaganda work in the suppression of Falun Gong. He was assisted by Li Dongsheng [4].

The involvement of persecuting Falun Gong by the members of the CCPCC Leadership Team to Deal with Falun Gong Problem and it's affiliated "610 Office"

Li Lanqing: He has been in charge of the nationwide suppression of Falun Gong since 1999 until 2003 when he retired. On November 26, 1999, he gave a special report entitled "A few issues in fighting with 'Falun Gong'" in a "Situation Report Conference" held in the Great Hall of the People in Beijing which was attended by 3000 people [22]. He directed the persecution in many areas such as Science and Technology [23], Education [24], Entertainment [25], Work for Senior Citizens [26], etc. In the national anti-Falun Gong Commendation Meeting [27] and Exhibition [28], he gave speeches to agitate hatred.

Luo Gan: Details about Luo Gan's directing the nationwide suppression of Falun Gong will be reported separately.

Ding Guangen: He took charge of the anti-Falun Gong propaganda, and hosted the national anti-Falun Gong Commendation Meeting [27] and Exhibition [28], and gave speeches.

Jia Chunwang: He organized, arranged and promoted the persecution of Falun Gong by the national public security system [29], public security boarder forces [30] etc. when he was on duty. He slandered Falun Gong in an interview by the Xinhua News Agency during the National People's Congress [31]. He also demanded the Justice Department of Japan to be involved in the persecution of Falun Gong [32]. He claimed that the fighting with Falun Gong is the work of focus of the national public security agency [33]. His slandering speeches against Falun Gong in the graduation ceremony of the public security officer training session was published in Hong Kong The Mirror under the alias name of "Zhong Shan" and was massively reprinted by CCP media [34,35].

Xu Yiongyue: (information temporarily not available)

Wang Maolin: He is comprehensively in charge of the daily operation of the suppression of Falun Gong. He managed the nationwide action of destroying Falun Gong Publications [36]. He participated and hosted the anti-Falun Gong Public lectures and exhibitions [39] nationwide [37] and in Beijing [38]. He, together with the No.1 Director Zhou Qiang, and the Director Zhao Yong of the Youth Corps Central Committee secretariat, organized the persecuting Falun Gong action of "anti-evil cult by Youth Civilization Communities" that involved more than 100 cities in the country [40]. He wrote the preface for the anti-Falun Gong book of Refuse Evil Cult [41], and the Schools Refuse Evil Cult [42], which is for middle and elementary school students. He personally went to the Basic Unit [11] and Masanjia [43] Forced Labor Camp to command the persecution.

Liu Jing: He hosted press conference under the title of the Person in charge of the Office of Preventing and Handling the Evil Cult Problem of the State Council, and slandered Falun Gong by using the issues of Tiananmen Square self-immolation and the principles and policies CCP used in the persecution and defended the persecution [44]. He directed the "concentrated transformation" of Falun Gong practitioners in the provincial level [15]. He went to Masanjia labor camps many times to facilitate the establishment of "Masanjia Brainwashing Center" [45], and was involved in Hong Kong Falun Gong issue [46].

Yuan Yin: (information temporarily not available)

Li Dongsheng: As the Deputy Minister of the the Ministry of Propaganda of the People's Republic of China, and the Assistant of the Minister Liu Yunshan [4], he should be mainly responsible for the anti-Falun Gong propaganda by the major media including CCTV, in the 4 years. As a special Consultant in the Chinese delegation in the 57th Conference of the UN Human Right Commision, he was interviewed [47] and addressed the women related issues and slandered falun Gong [48]. As a Deputy Director of the "610 Office" (The Office of Preventing and Handling the Evil Cult Problem of the State Council), he accompanied the head of the Leadership Team to Deal with Falun Gong Problem, Li Lanqing to conduct inspection in every part of the country. [17, 49].

Wang Xiaoxiang: He attended and addressed in the "Conference in fighting with Falun Gong in Beijing" [18]. As a special Consultant in the Chinese delegation, he gave speeches in the 58th Conference of the UN Human Right Commision, slandering Falun Gong and its founder and defending for CCP's persecution of Falun Gong[50].

Dong Junfa: He participated the "national circuit lecture group of 'fighting with Falun Gong'" in the title of inspector of the Office of Preventing and Handling the Evil Cult Problem of the State Council [19]. He inspected Masanjia Forced Labor Camp and acknowledged the persecution of Falun Gong practitioners by the labor camp [45].

Gao Xiaodong: He inspected and directed the suppression of Falun Gong at lower government levels [20].

Liu Yunshan: He is in charge of the nationwide anti-Falun Gong propaganda [4]. He hosted the national conference of "Report of Exemplary Deeds in Fighting with 'Falun Gong'" [37]. He gave speeches in the opening ceremony of the large scale anti-Falun Gong exhibition [39]. He convoked anti-Falun Gong Symposium and gave major speeches in the title of Director of the CCP Civilization Manages [51].
