Summary

1. I am Director Wu, Director Wu Bo.
2. You make a request with the designated COVID-19 hospital first, and then ask them to request the Chen Jingyu's team in Wuxi for a consultation, and then we will go to the consultation to make an assessment. If there are good surgical indications, we will make preoperative preparations, and if not, we cannot do this operation.
3. If he tests positive, a lung transplant can't be done, he would have to wait until he is free of the virus before it can be done. This is the first one. The second one is whether his condition is irreversible. If there is a reversible change in the lungs, we can't do it. It must be an irreversible change. Third, we can only do it if he is in a critically condition and it must be done to save his life.
4. The entire medical procedure takes a quite long time. But I don't know exactly how many days it will take.
5. A COVID-19 lung transplant operation is cost free, as it's paid by the state.

Doctor Jiang: Hello? How are you?

Investigator: Hello, hello!

Doctor Jiang: Hello?

Investigator: Hey, how are you? Where is this?

Doctor Jiang: Hello?

Investigator: Hey, can you hear me?

Doctor Jiang: Yes, I can, now.

Investigator: Hello, may I have your last name? Is this Doctor Zhou, Doctor Zhou Min?

Jiangyan City: Ah, no, he has already left.

Investigator: Ah, he's gone. Now who is with your people's hospital, who works over there?

Doctor Jiang: Ah, I...I work here.

Investigator: What's your last name? Your last name? Is this Wu Bo?

Doctor Jiang: My last name is Jiang. Who is this?

Investigator: Right, I am in our system. Because my father-in-law is not very well now, because we, we also want to do it. But I just don't know how probable or feasible it is?

Doctor Jiang: Are you... who are you?

(Doctor Jiang: ... have been calling and found us here... Jiang: This is another patient in the same situation. Wu: Who is it? Jiang: This is another patient in the same situation.

Now you come to answer it. Wu: Okay, then I will do it.)

Wu Bo: Hello?

Investigator: Ah, how are you? May I have your last name?

Wu Bo: Mine is Wu, it's Wu.

Investigator: Ah, you are Doctor Wu, Wu Bo, right? Is this Director Wu?

Wu Bo: Yes, this is Director Wu, ah, Wu Bo, ah, Director Wu Bo, right.

Investigator: Hi, how are you? Well, here's my situation. As I read a report in the newspaper some time ago, your People's Hospital had done a lung transplant. Because my father-in-law is now in Suzhou, and now he's infected (with Covid-19), I'd like to know that through what kind of connections we can also have such a lung transplant done?

Wu Bo: For this, you need to go through a procedure here, first of all, we have a procedure when a patient tests positive (with COVID-19).

Investigator: Uh, yes.

Wu Bo: Well, you do this, you let...you first make a request with the designated COVID-19 hospital in Suzhou.

Investigator: Okay.

Wu Bo: Then let him find Chen Jingyu's team in Wuxi to request a consultation, and then we will go to the consultation. After the consultation, we will make an assessment. If there are good surgical indications, we will make some preparations before the operation. But if there aren't any good indications, we can't do this operation, okay.

Investigator: How long does it usually take? How many days will it take?

Wu Bo: The whole process takes a quite long time. The first one depends on whether he

would test positive or negative with COVID -19.

Investigator: Oh, then?

Wu Bo: If he tests positive, in that case, a lung transplant cannot be done, he would have to wait until he is free of the virus before it can be done. This is the first one; second, is his condition irreversible? To have it, he must have gone through irreversible changes; the third one is that his condition becomes critical, and then it is needed to save his live, then we can do it for him.

Investigator: Oh, he must meet these three requirements, right?

Wu Bo: At least!

Investigator: If it is in the early stage, should we get that done in Suzhou by asking President Chen to go there, or we...

Wu Bo: Listen to me, listen to me.

Investigator: Oh, a little anxious.

Wu Bo: You need to first, as I said before, you have to make a request with your hospital.

Investigator: I understand.

Wu Bo: Then contact Chen Jingyu's team on our side through the hospital.

Investigator: Oh, it's President Chen who takes care of all these procedures, right?

Wu Bo: Right, right.

Investigator: We just need to submit an application, right?

Wu Bo: You only need to apply locally, for example, you can tell whichever hospital you stay in, "I am considering now...I am going to have a lung transplant now, please make an assessment for me."

Investigator: Oh. Go to your hospital for the transplant.

Wu Bo: Or you can ask the lung transplant team to make an assessment.

Investigator: I want to ask, is the operability of this thing, or the success rate okay? It's because I've read two reports about it in our country now, one is in Zhejiang and the other is at your place. But neither is...

Wu Bo: Right, right.

Investigator: Yes, that's operable, right?

Wu Bo: That, that should be operable.

Investigator: So (the patient) must be assessed first, then how many days do you think this process will take? Well, as you said, we go through the assessment...

Wu Bo: That I don't know. That is a new issue we just discussed. I don't know how many days it will take. Okay.

Investigator: Oh, you are not sure. Well, excuse me Director Wu, could you tell me how much we need to prepare, as we definitely don't have medical insurance?

Wu Bo: Well, about that, you don't need to worry about the money, since it's the state that pays for it!

Investigator: Ah! I don't need to pay for that? Oh, then I got it.

Wu Bo: Right.

Investigator: So that is the case, now I got it, okay, thank you Director Wu.

Wu Bo: Alright, alright, Good.

Investigator: Well, I'll get back to you, and we'll go from there.

Wu Bo: It's okay. It's alright.

Investigator: Okay, thank you, bye.

Wu Bo: Alright, okay, okay.
