Doctor Zhu: Who is this?

Investigator: Ah...is this Chinese People's Liberation Army No. 458 Hospital?

Doctor Zhu: Hi, hello.

Investigator: Ah, hello! Well, I have a question....

Doctor Zhu: Who is this?

Investigator: I am a relative of a patient. Uh, my family has a patient who needs a kidney transplant. He joined the waiting list before the pandemic, no, he didn't join it, rather, it was the tissue typing that he got finished. Then, the pandemic came, and everything was put aside. Now we want to get a kidney transplant done again.

Doctor Zhu: Where did you get the tissue typing done?

Investigator: In the South....

Doctor Zhu: Ah?

Investigator: At Nanfang Hospital of Southern Medical University.

Doctor Zhu: It was at Nanfang Hospital, right?

Investigator: Ah, yes.

Doctor Zhu: How old is he?

Investigator: 39.

Doctor Zhu: 39? What is the blood type?

Investigator: Ah, it's blood type B.

Doctor Zhu: Type B. The tissue typing results should be included, and HIPI, you know? Do you know what HIPI is?

Investigator: Uh, uh, well, all those tests I don't quite understand, so I will just bring all
