



Investigative Audio Recording 27.

Subject of Investigation: Zhou Benshun, Former Secretary-General of Central Political and Legal Affairs Commission, admitted live organ harvesting from Falun Gong practitioners

Date: November 2008

Summary

1. In November 2008, Zhou Benshun, the then secretary-general of the Central PLAC, accompanied Zhou Yongkang, the director of the Central PLAC, on a visit to Australia. A WOIPFG investigator disguising himself as Yang Hui, Head of the Second Department of PLA General Staff Headquarters, collected testimony from Zhou Benshun. Zhou admitted, "Such things as live organ harvesting from Falun Gong practitioners in our country, it does exist in our country."
2. Zhou Benshun was the vice secretary-general and later secretary-general of the Central PLAC from 2014 to 2013. Ultimately, he was one of the high-level officials and organizers involved in the implementation of harvesting organs from Falun Gong practitioners.
3. He involved the crime of genocide and crime against humanity. We urge the Chinese incumbent authority to disclose the crime of Zhou Benshun, Zhou Yongkang and Jiang Zemin for their persecution of Falun Gong and live organ harvesting from Falun Gong practitioners. WOIPFG will continue to unveil CCP's such crime.

Investigator: Is this Central PLAC secretary-general Benshun Zhou?

Benshun Zhou: Yes.

Investigator: This is Hui Yang, Head of the Second Department of PLA General Staff Headquarter.

Benshun Zhou: How are you, Hui Yang?

Investigator: There is something urgent.。

Benshun Zhou: Please go ahead.

Investigator: Our intelligence center in Australia under Second Department of PLA General Staff Headquarter reported somebody in your delegation contacted Australia intelligent agency.

Benshun Zhou: Oh, please go on.

Investigator: Upon our internal reliable intelligence, he might sell the state secrets. If they reach a deal, then this person might flee immediately.

Benshun Zhou: Please go on.

Investigator: Since this was reported from our intelligence center in Australia, I would like to know which staff in your delegation got involved with such state secret.

Benshun Zhou: Hey, who is calling please?

Investigator: This is Hui Yang, Head of the Second Department of PLA General Staff Headquarter.

Benshun Zhou: You are Hui Yang.

Investigator: Yes.

Benshun Zhou: Could you please check through other channel?

Investigator: It is very urgent now. We have this intelligence in hand. If we don't take any action and something do happen, we will have responsibility. So we hope you could help us to narrow down the investigation scope.

Benshun Zhou: Could you please make an official phone call through other channel?

Investigator: Hum? If you were in the state, I would be able to call the confidential number. But you are not in the state and it is very urgent, I could only make this phone call.

Benshun Zhou: The problem is I couldn't confirm your identity.

Investigator: This person used this to bargain with Australia intelligence agency.

Benshun Zhou: I couldn't confirm your identity now. And we don't have any contact before. Let's do this way. Could you contact the Embassy and Consulate first?

Investigator: The problem is your person might reach the deal anytime soon.

Benshun Zhou: You need to go through domestic channel. Now that you are with PLA General Staff Headquarter, you know every time it needs to go through official channel, through Embassy and Consulate. All right?
