#### Summary

During Guo Boxiong’s visit to Central America from October 23 to November 4, 2011, a WOIPFG investigator had a phone conversation with Guo, in the name of the secretary of Zhou Yongkang, the former head of the Central Political and Legal Affairs Commission. Guo did not deny the existence of “live organ harvesting from imprisoned or detained Falun Gong practitioners for transplant operations.” He only emphasized that further discussion should be conducted “through a confidential phone line.”

#### Phone Investigation Recording

Guo Boxiong: Hello?

Investigator: Hello, is that Vice Chairman Guo Boxiong of the Central Military Commission?

Guo Boxiong: Who are you?

Investigator: I am the secretary of Zhou Yongkang, director of Central Political and Legal Affairs Commission. There is an incident of serious disclosure of a state secret, which is related to the army, and the situation is urgent. Secretary Zhou Yongkang wants me to ask you some questions, in order to narrow the scope of investigation.

Guo Boxiong: Where are you, now?

Investigator: I am in Beijing right now. We would like to know if there is anyone in the Central Military Commission who knows about the state secret of live organ harvesting from Falun Gong practitioners for organ transplant operations?

Guo Boxiong: Well, let me call you back, okay? ...

Investigator: I am... now... there is no problem, I am calling through the confidential phone line of our embassy.

Guo Boxiong: I will call you tonight, okay?

Investigator: This situation is urgent, we...

Guo Boxiong: What is your surname?

Investigator: Oh, my surname is Tan,

Guo Boxiong: So Secretary Tan, I will call you tonight, okay?

Investigator: Ah?

Guo Boxiong: I'll call you tonight, okay?

Investigator: This call is through a confidential phone line.

Guo Boxiong: I will initiate the phone call to you through a confidential phone line, okay?

Investigator: No, I am already using a confidential line in this call.

Guo Boxiong: I will contact you at night, okay?

Investigator: Ah, this is urgent...

(Guo hung up the phone.)
